Board of Registration of Massage Therapy July 14, 2025 Public Meeting Minutes

A hybrid public meeting of the Massachusetts Board of Registration of Massage Therapy (the Board) was held in person and remotely via video and telephone conferencing pursuant to Chapter 20 of the Acts of 2022, allowing remote participation by Board members and the public.

Meeting Called to Order

The hybrid meeting convened after the close of the public hearing. At approximately, 10:40 AM, Paul Andrews confirmed quorum via roll call which showed the following members participating in person: Paul Andrews, Pallas Hutchison, and Anthony Chui. Alexei Levine participated remotely.

Curriculum Review

• Flavia Leal School of Massage Therapy- Paula Fallon, Director of Education, was present along with Telma Ross, Director of Practical and Clinical Education. Alexei Levine raised areas of concern in this curriculum review, including in connection with course content, attendance requirements, labs versus homework, mannequins, language of instruction, and foreign transfer credits. Paul Andrews raised additional concerns, including in connection with allergies to lubricants, references to skincare and exfoliation, defining supervision, and the terms therapeutic massage and medical massage. Paula Fallon addressed the question of attendance, with a portion being online with theory, and then in class students would be applying the theory to the practical. Alexei Levine pointed out that online courses have to be scheduled classes that are taught by a live instructor. Ms. Fallon discussed the issue of teaching in other languages than English. She confirmed that textbooks are only in English. Paul Andrews suggested that the Board provide its concerns in consolidated written form to assist Ms. Fallon. This item was tabled.

• Kerry Cassidy provided updated numbers for individual massage therapists and establishment applications.

Discuss other matters not reasonably anticipated within 48 hours in advance of meeting.

- Alexei Levine noted his desire for the Board to pursue a policy that would prohibit transfer of credits from outside of the United States and require that students be told in advance of enrollment that a licensing exam will be required.
- Mark Molloy and Greg Hurd stated that they have encountered questions regarding draping requirements.
