1. <u>Meeting Opening and Introductions</u>

Chief Matthew Belsito, Chairman, opened the meeting at approximately 10:02 a.m. The Chair introduced himself, followed by the introductions of the Council members, Department of Fire Services' employees, and public members in attendance.

2. <u>Approval of October 25, 2023, Meeting Minutes</u>

Deputy Secretary Terrey made a motion to accept the minutes of the meeting held, Wednesday, October 25, 2023. The motion was seconded by Iain McGregor. No further discussion. Unanimous roll call vote was completed.

3. Discuss Tech Rescue Correspondence

Paul Betti received correspondence from Ben Podsiadlo at Office of Grants and Research (OGR), asking what team typing we have selected in each region. This is because OGR received an equipment grant request from Region 4. Mr. Podsiadlo was told that no decisions had been made on that but that it would be a future topic at the regional directors meeting that Paul Betti is setting up.

4. <u>Subcommittee Reports</u>

- a. Equipment nothing to report
- b. Policy/SOG did not meet in November, the next scheduled meeting is 12/12/23
- c. Training joint meeting with membership on 11/21/23, Jason Saunders reported that they worked on the activation flyer flowchart. This documents shas been sent to SOG subcommittee. They also discussed breaking down the training requirements for each member
- d. Membership see Training above
- e. Mobex Iain McGregor indicated that their meeting was held on 11/21. The working group finalized the objectives in the HSEEP format. They finalized the draft of the exercise plan as well as the budget request. In December all documents will be sent up to the council for review before going to OGR

5. <u>Regional Reports</u>

- a. Region 1 Mark McCabe indicated that Dukes County was put on standby to support a commercial dive team going into Tisbury water tower. They have been doing training with the personnel they have. Barnstable County did train in October for trench, November on ropes and December they are scheduled to be doing ropes part 2. Working on getting Petzl I'ds, asap's and clutches as well as rope. Norfolk County did a confined space drill in October and a rope drill in November. They had 1 activation to retrieve a deceased person from a well that had been missing. They are also working on getting more equipment like Petzl I'ds, asap's and clutches. Bristol & Plymouth counties had no update
- b. Region 2 no update
- c. Region 3 Chief Belsito reported that D7 did trench rescue training, D8 & D14 have been doing ongoing training
- d. Region 4 Daryl Springman stated that they were activated to Lenox for a missing person search, this included multiple rappels down the rock face. Daryl attended the quarterly statewide SAR meeting. At the beginning of next year, they are planning to look at trench SOP's
- e. Region 5 Rick Nelson reported that there were no activations since last meeting. For training, 2 months ago they did water rescue in Andover and then

Structural collapse training in Reading as well as some rope and trench rescue training. The biggest problem is trucks to transport their equipment, stuff is starting to age out

Update on MOBEX funding

Chairman Belsito met with the executive board of FCAM in early November, FCAM is in support of a MOBEX but just not at this time. They would like to see legislation further along as well as see the team structure fall under DFS. Iain McGregor brought up that the MOBEX subcommittee was created in September 2022 per the coordinating council. The MOBEX subcommittee has been meeting actively since February of 2023. Marshal Davine asked where the funding would come from, Iain's comment was to ask for funding from the OGR state share funding. Iain further asked for direction from the council so he could bring it back to his subcommittee. Marshal Davine asked Chairman Belsito to get a response in writing from the FCAM board to see their stance on the MOBEX. Further discussion was had on what are the next steps. Comments from Deputy Marshal Fournier and Glenn Rooney relayed that until legislation passes, DFS and/or the MTRCC is limited. If legislation passes, then the funding can come but we need to put an accurate budget together. Add budget review discussion to the December meeting. The proposal is to work backwards on the budget to provide same service that the regions provide now, then add other services as the budget allows. Iain McGregor and Paul Betti to work to clean up the existing budget.

b. Update on Tech Rescue legislation

Iain McGregor stated that senate bill 1596, did come out of committee last session and was voted favorably by one chamber. It is still in public safety subcommittee and people have spoken positively on behalf of this bill, so we are hopeful that it passes by end of this session. Senator Timilty then filled senate docket 2755 in September, it is still in committee, and it has not had a hearing yet. This establishes the Special Operation division within DFS as well as changing the coordinating council to an advisory council. The Marshal would then administer the Tech Rescue service fund, also included is a \$5000 stipend.

- a. Paul Betti asked Chairman Belsito if we had heard anything on selection of our 7th member of the coordinating council. Glenn Rooney stated that there are several pending vacancies with the boards & commissions office, and we have not received an update at this time.
- b. Iain McGregor suggested to Chairman Belsito that we write a letter of support of bill 1596 to the public safety subcommittee. Chairman Belsito asked Glenn Rooney if that is acceptable in which we were told yes. Chairman Belsito asked Paul Betti to draft this letter.
