# MassHealth Municipally Based Health Services Bulletin 13 April 2008

TO: Municipally Based Health Service Providers Participating in MassHealth

**RE:** Changes in Department of Education Placement Categories

#### Background

This bulletin provides instruction on the service codes and modifiers that municipal-based health-service providers participating in MassHealth should use with updated special-education placement categories recently issued by the U.S. Department of Education (DOE) for children aged three to five years, including the rates payable for these codes.

#### Changes

The U.S. DOE changed the placement categories and their definitions for students aged three to five with disabilities for the 2006–2007 school year. The changes are effective for all school districts in the Commonwealth for the 2007-2008 school year. For your convenience, the table below lists the new placement categories, the service codes and modifiers for these categories, the code and modifier descriptions, and the corresponding rates.

In regular early- childhood program 40% to 79% of the time	T1018-U1	School-based individualized education program (IEP) services, bundled	Use for full or partial inclusion program	\$12.41/day
In regular early- childhood program less than 40% of the time	T1018-U2	School-based individualized education program (IEP) services, bundled	Use for substantially separate classroom	\$26.95/day
Substantially separate class	T1018-U2	School-based individualized education program (IEP) services, bundled	Use for substantially separate classroom	\$26.95/day

Public separate day school	T1018-U3	School-based individualized education program (IEP) services, bundled	Use for day school	\$50.62/day
Private separate day school	T1018-U3	School-based individualized education program (IEP) services, bundled	Use for day school	\$50.62/day
Residential facility	T1018-U4	School-based individualized education program (IEP) services, bundled	Use for residential school, PL1 only or PL2, documenting cost-shared residential placement	\$52.67/day
In regular early- childhood program at least 80% of the time	T1018-U5	School-based individualized education program (IEP) services, bundled	Use for home- based or center-based early childhood program	\$120.79/ week
