- Turn on Right SOUTHWEST CUTOFF(US-20)

- Take ramp toward I-290
- Bear Left on MCKEON RD
- Bear Right on MILLBURY ST(RT-122A)
- Turn Left on CLIFF ST
- Turn Right on GRANITE ST
- Continue on PARK HILL AVE
- Turn Right on HOLMAN RD
- Arrive at 13 HOLMAN RD, MILLBURY, on the Left

**From South-West (Hartford, CT)**

- I-84 E
- Take the WORCESTER/BOSTON exit onto I-90 E (Toll applies)
- Take exit #10A/WORCESTER (RT-146)/PROVIDENCE (US-20) (Toll applies)
- Turn Left on ROUTE 20 CONN toward US-20/AUBURN/WESTBOROUGH
- Turn Right on SOUTHWEST CUTOFF(US-20)
- Turn Right on GRANITE ST
- Continue on PARK HILL AVE - go 0.6 mi
- Turn Right on HOLMAN RD
- Arrive at 13 HOLMAN RD, MILLBURY, on the Left
