Article 13: Citizen Petition-Petition General Court- Age Exemption- Jesus Melendez. To see if the Board of Selectmen will vote to Petition the General Court to enact Legislation so that Jesus Melendez shall be eligible to have his name certified for original appointment to the position of Firefighter for the Town of North Andover, notwithstanding his having reached over the age of 32 before taking the civil service examination in connection with that appointment. Jesus Melendez shall be eligible for appointment to the position of Firefighter in the Town of North Andover if he otherwise qualifies and is selected for employment under Chapter 31 of the General Laws, any regulations of the civil service commission, and any lawful hiring practices for the Town of North Andover.

Adjourned Town Meeting March 17,1928.

Article 5.

Voted that all free cash in the treasury not otherwise appropriated be applied to the reduction of the tax levy for the current year.

Article 6.

Voted: that the Town Treasurer, with the approval of the Selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1928, and to issue a note or notes therefor, payable within one year; any debt or debts incurred under this vote to be paid from the revenue of said financial year.

The vote was unanimous.

Article 7.

Voted to raise and appropriate \$22.90.

Article 8.

Voted that action be postponed and that the committee be continued and enlarged by three more members and instructed to bring in revised plans.

Article 9.

Voted to raise and appropriate the sum of \$4975.00 for purposes mentioned in this article.

Article 10.

Voted to raise and appropriate the sum of \$2500.00 for the purchase of land mentioned in this article.

Article 11.

Voted to accept report of committee as progressive and that the committee be continued. The Moderator was empowered to fill vacancies when occuring in town committees.

Article 12.

Voted to raise and appropriate the sum of \$3500.00 as called for in this article.

Article 13.

The Board of Public Works named as committee.

Article 14.

Voted to accept section 48 of chapter 31 of the General Laws, in so far as it applies to regular or permanent force in the Police Department. A hand vote was taken.

114 voted in favor. 83 voted against.
