DECISION

TIDES AT NAHANT INC. D/B/A TIDES RESTAURANT 2-B WILSON RD.
NAHANT, MA 01908
LICENSE#: 0760-00010

VIOLATION DATE: 06/21/2017 HEARING DATE: 10/17/2017

Tides at Nahant Inc. d/b/a Tides Restaurant (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, October 17, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Di Cicco's Report.

The following documents are in evidence:

- 1. Investigator Di Cicco's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.
- A. Photographs of Signs Inside Premises.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Wednesday, June 21, 2017, at approximately 6:54 p.m., Investigators Carey and Di Cicco ("Investigators") investigated the business operation of Tides at Nahant Inc. d/b/a Tides Restaurant.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Bud Light beer, for four dollars and fifty-two cents (\$4.52). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 15 years with no prior violations, the Commission issues a **WARNING**.
