

## How to name your PDF documents when filing your petition for admission

Your filing could be rejected for incorrect file upload names. File naming errors are the most likely reasons for an unsuccessful e-filing submission. To minimize the risk of filing errors, we are providing the suggested **File Name** for each possible upload document. The computer generally applies the .pdf suffix. Be sure .pdf it is **not** duplicated (i.e. Smith.John.Rec.pdf.pdf).
