



Short-term Maintenance Projects – Project Areas Nantasket Beach Reservation Floor Hockey Rink






Goals:

- Eliminate expensive conduit replacement projects
- Meet EO 594: Create Net Zero Facilities
- Prevent issues with wind loading
- Prevent issues with bird roosting
- Choose poles that are as recessive as possible
- Provide remote monitoring

Schedule:

Installation beginning Spring 2023







North Area

- 1. Repave DCR Parking Lot A (FY23)
- 2. Repave Boardwalk (abutting Hull Shore Drive angled parking)
- 3. Hull Shore Drive (continuing into FY23):
- Replace and/ or add leaching CBs
- Repave angled parking and road



Short-term Maintenance Projects – North Area Nantasket Beach Reservation Floor Hockey Rink



Central Area

- 1. DCR Parking Lot C:
- Repave parking
- 2. Repave Boardwalk (excluding area in front of MJM)
- 3. DCR Parking Lot B (continuing into FY23):
- Replace and/ or add leaching CBs
- Install solar lighting
- 4. DCR Parking Lot D (continuing into FY23):
- Replace and/ or add leaching CBs
- Install solar lighting
- 5. Bernie King Pavilion:
- Replace dumpster enclosure



Short-term Maintenance Projects – Central Area Nantasket Beach Reservation Floor Hockey Rink



South Area

- 1. Repave Boardwalk
- 2. DCR Parking Lots E & F (continuing into FY23):
- Replace and/ or add leaching CBs
- Install solar lighting
- 3. DCR Parking Lot G:
- Pending public outreach, remove floor hockey rink and replace with parking or renovate.






Floor Hockey Rink Existing Conditions

2. Future: 256 spaces (includes 10 bus spaces)







Master Plan: Parking Lot G Nantasket Beach Reservation Floor Hockey Rink
