DECISION

J.A.C. FINE WINE & SPIRITS INC. D/B/A FRIENDLY LIQUORS 1567 ACUSHNET AVE.

J.A.C. Fine Wine & Spirits Inc. d/b/a Friendly Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, July 25, 2017, regarding an alleged violation of 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Velez's Report.

The following documents are in evidence:

- 1. Investigator Velez's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Wednesday, May 13, 2017, at approximately 6:09 p.m., Investigators Binienda and Velez ("Investigators") investigated the business operation of J.A.C. Fine Wine & Spirits Inc. d/b/a Friendly Liquors.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 6-pack of Bud Light beer, for five dollars and ninety-nine cents (\$5.99). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
