After a hearing on December 15, 2015, the Commission finds Swamini LLC d/b/a Zully's Wine & Spirits violated M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age (1 Count).

Therefore, the Commission **suspends the license for four (4) days of which two (2) days will be served and two (2) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**

By decision dated December 17, 2014 the Commission had previously ordered a three (3) day license suspension but had held the suspension in abeyance for a period of two (2) years provided no further violations occurred. Based on the violation found above, the Licensee violated the conditions of that three (3) day suspension being held in abeyance. The Commission hereby orders that suspension to be served on and after the two (2) day suspension. The Licensee will serve a total five (5) days.

A request by the Licensee to reschedule the suspension for a later date has been allowed by this Commission.

The suspension shall commence on Wednesday, March 30, 2016, and terminate on Sunday, April 3, 2016. The license will be delivered to the Local Licensing Board or its designee on Wednesday, March 30, 2016 at 9:00 A.M. It will be returned to the licensee on Monday, April 4, 2016.
