## **DECISION**

THE WHALING CITY CLUB 447 BELLEVILLE AVE NEW BEDFORD, MA 02746 LICENSE#: 077800040 HEARD: 08/07/2012

The Whaling City Club (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, August 7, 2012, regarding an alleged violation of 204 CMR 2.05 (1): Permitting Gambling. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Teehan's Report.

The following documents are in evidence:

- 1. Licensee's Stipulation of Facts;
- 2. Investigator Teehan's Investigative Report dated February 29, 2012; and
- 3. Copy of Receipt.

## **FACTS**

- 1. On Wednesday, February 29, 2012, at approximately 11:45 p.m., Investigators Kenny and Teehan conducted an investigation of the business operation of The Whaling City Club in response to a complaint filed with this agency.
- 2. Investigators identified themselves to the bartender on duty, Mr. Benbinda Tavares, and informed him of the complaint and investigation.
- 3. Investigators observed one (1) automatic amusement device in the bar area.
- 4. Investigator Teehan placed one (1) dollar in United States currency into the device and made a bet.
- 5. Investigator Teehan printed out the receipt and observed the points reset.
- 6. Mr. Tavares stated that the licensee does payoff for winnings on the automatic amusement devices.
- 7. Mr. Tavares stated that when an individual completed play and printed a ticket from the machine, they would hand it to the bartender on duty. The bartender on duty collected the receipt in an envelope.
- 8. Mr. Tavares further stated that the vending company, Shen Communications, comes once a week and reimburses the licensee for the payoff winnings from the tickets.
- 9. Investigators informed Mr. Tavares of the violations and that a report would be submitted to the Chief Investigator for further action.
