### **Green Communities Designation Deadlines Set**

Across the Commonwealth, cities and towns are reaping the benefits of clean energy leadership as designated <u>Green Communities</u>. DOER expects to expand this number in 2023 with two opportunities to submit designation applications. The Spring deadline is **5 pm, March 31** and the fall deadline is **5 pm, September 29**.

<u>Guidance for aspiring Green Communities</u> regarding how to meet the five criteria for designation specified in the Green Communities Act is posted on the Green Communities website. Prior to submitting an application, municipalities may request a preliminary consultation with the Green Communities Division to discuss their progress toward meeting any or all of the five designation criteria. To schedule a preliminary consultation, contact your Green Communities Regional Coordinator.

**Climate Pollution Reduction Grants Offered by EPA** 

Through a provision of the Inflation Reduction Act, the U.S. Environmental Protection Agency (EPA) is offering **Climate Pollution Reduction Grants** (CPRG) to states, territories, tribes, air pollution control agencies, **and local governments to develop and implement plans for reducing greenhouse gas emissions** and other harmful air pollution.

A total of \$5 billion has been allocated for this two-staged grant program. The EPA will first award \$250 million for noncompetitive planning grants, followed by \$4.6 billion for competitive implementation grants.

The CPRG seeks to provide flexible support to states, tribes and local governments regardless of where they are in their climate planning and implementation process. Potential projects could further **goals and policies for clean energy, energy efficiency**, and more.

The EPA anticipates announcing the non-competitive planning grants as soon as March 1, 2023. Visit the <u>CPRG website</u> to view the introductory Feb. 15 webinar and register for informational webinars on **March 2**<sup>nd</sup> **and 7**<sup>th</sup> on the non-competitive planning grants.

## **Energy Efficiency Conservation Block Grant Webinar**

The U.S Department of Energy (DOE) released application materials for the Bipartisan Infrastructure Bill (BIL)-funded Energy Efficiency and Conservation Block Grant (EECBG) Program for states, local governments, and Tribes.

Applications for the EECBG are now open for communities with over 35,000 residents, which will receive a <u>direct grant</u> from DOE. Smaller communities can apply for sub-grants that will be administered through DOER later this year. EECBG funds can be used for <u>implementing strategies</u> to reduce energy use, to reduce fossil fuel emissions, and to improve energy efficiency.
