Dear Ms. Michalik:

The Massachusetts Clean Waters Act (M.G.L. c.21, s.26-53) was amended by Chapter 246 of the Acts of 1973 to authorize the Massachusetts Department of Environmental Protection ("MassDEP") to regulate discharges into all waters of the Commonwealth, including groundwaters. MassDEP regulates discharges through the issuance of discharge permits which impose limitations on the amount of pollutants which may be discharged in effluent, together with monitoring and reporting requirements and other conditions to ensure adequate treatment of all liquid wastes prior to discharge.

MassDEP has reviewed your Notice of Intent (the "NOI") application for coverage under the General Permit for Privately Owned Wastewater Treatment Facility serving a 252-bedroom apartment complex, submitted on April 6, 2018, on behalf of the Madison Place Southborough, LLC, located at 1200 Madison Place, Southborough, MA to discharge treated sanitary sewage from a proposed on-site wastewater treatment facility, to the ground. MassDEP has determined that the NOI is complete and that the proposed facility complies with the requirements for coverage under the *General Permit for Small Privately Owned Wastewater Treatment Facilities that Discharge Treated Effluent to the Ground Water and the Discharge from Said Facilities*. 
Enclosed herewith is a copy of the public notice for your NOI. The enclosed public notice should be published to start the thirty (30) day public comment period.
