#### Application for Non-Resident Temporary License to Carry Firearms – IMPORTANT INFORMATION

All firearms licenses in Massachusetts are issued through the Massachusetts Instant Record Check System (MIRCS). MIRCS is a computer-based application used to manage, process, and monitor firearms licensing statewide.

Every applicant is required to appear in-person at the Firearms Records Bureau (FRB) for the first non-resident license to carry (LTC) application.

Renewals will be processed solely by mail, and <u>you will still need to renew your LTC annually</u>. However, subsequent in-person appearances may be required at the discretion of the FRB. If required, you will receive an appointment notice by mail or email with your scheduled date and time to appear at this office. Appointments will be scheduled in the order that completed applications are received.

FRB will continue to process fingerprint-based background checks annually as required by statute (MGL c. 140, § 131F) for all new and renewal applications.

Applicants should apply for renewal a minimum of 90 days in advance.

Pay close attention to the application instructions, as a mistake on the application or omission of required documentation will result in a delay in issuance or a denial of the application.

## **Non-Resident Application Instructions**

Non-Refundable Application Fee: \$100.00 Valid: 1 year, unless issued for employment (see #5)

The following items must be received and applications must be complete to be processed:

- 1. **Fee:** The **non-refundable** application fee is \$100.00. Only bank or postal money orders and certified bank checks made payable to "Commonwealth of Massachusetts" will be accepted as payment. *Cash, personal checks, or business checks are not accepted.*
- Firearms Safety Course: First time applicants must submit a copy of a certificate showing completion of a
  Massachusetts Basic Firearms Safety Course. This course must have been taken with an instructor who is
  certified by the Colonel of the Massachusetts State Police (ask your instructor prior to taking the course if he is
  certified in Massachusetts).

A Massachusetts Division of Fisheries and Wildlife hunter education course is a valid substitute for the Firearms Safety Certificate.

A safety course or certificate is **not** required if you

- 1) Held a Massachusetts non-resident LTC or Massachusetts resident LTC on or after June 1, 1998, or
- 2) Are a current member of the United States Military or the Massachusetts National Guard. You must submit a copy of your most current military identification.

#### 3. Immigration Documentation:

Permanent residents (green card holders) or those in the United States on a lawful, temporary status: enclose a photocopy of your immigration card or VISA (containing the alien registration number) and passport (containing passport number). A LTC may ONLY be issued to a non-resident, non-citizen (alien) for the purpose of firearms competition.

*Naturalized citizens*: include your alien registration number (ARN) *and* the number on the naturalization certificate (or a copy of your naturalization certificate) or a copy of your US Passport.

- 4. **Home Address:** All applicants must complete the information for street, city/town, state, and zip code. *P.O. Box numbers are not accepted for residential address.*
- 5. Applications Submitted for Employment Purposes, valid for two years: Military personnel who are stationed within the territorial boundaries of the Commonwealth or persons employed by a bank, public utility corporation, a firm engaged in the business of transferring money, or a firm licensed as a private detective agency may apply for a license which may be valid for two years. To qualify:
  - Military personnel must submit a photocopy of their military ID, and have written consent from their commanding officer.

- Private detective agencies must be licensed in the Commonwealth under the provisions of M.G.L. c. 147, as a private detective agency, guard or patrol. A photocopy of the company's Massachusetts license must accompany the application.
- Persons employed by a bank, public utility corporation, a firm engaged in the business of transferring money, or a firm licensed in Massachusetts as a private detective agency, must have the application endorsed by his/her employer by submitting a letter from their employer on company letterhead indicating his or her current employment.
- 6. **Self-addressed, stamped envelope**: Used to mail the completed license.

\*Applications must be complete and accurate\*

\*Inaccurate or false information will result in a denial of the application\*

#### Important:

- All applications are processed through the mail; walk-in service is *not* available.
- If you are a first-time or renewal applicant that requires an in-person appearance, you will be contacted by mail or email within 2-3 weeks of receipt of your application with your scheduled appointment date.
- If you are a renewal applicant and do not require an in-person appearance, your application will be processed solely through the mail.
- A LTC may ONLY be issued to a non-resident, non-citizen (alien) for the purpose of firearms competition.
