Required Fiscal Year 2027 Appropriation: **\$107,244,875**

This Commission is hereby furnishing you with the amount to be appropriated for your retirement system for Fiscal Year 2027 which commences July 1, 2026.

Attached please find the portion of the Fiscal Year 2027 appropriation to be paid by each of the governmental units within your system. The allocation by governmental unit was determined by Gallagher as part of their January 1, 2024 actuarial valuation.

The current schedule is due to be updated by Fiscal Year 2028.
