Observations and Recommendations

- 1. The inmate population was 308 at the time of inspection.
- 2. The CSP recommends keeping a copy of the list of individuals with blood borne pathogen training in the medical waste binder for increase ease of access.
- 3. During the inspection of the kitchen, the CSP observed drain flies throughout the facility with a concentration of insects in the warewashing areas. The CSP recommends increasing the frequency of cleaning in these areas, including the non-food contact surfaces, to diminish the conditions that are attracting and/or harboring insects.

This facility does not comply with the Department's Regulations cited above. In accordance with 105 CMR 451.404, please submit a plan of correction within 10 working days of receipt of this notice, indicating the specific corrective steps to be taken, a timetable for such steps, and the date by which correction will be achieved. The plan should be signed by the Superintendent or Administrator and submitted to my attention, at the address listed above.
