

PUBLIC NOTICE

The Retirement Board members (the “Board”) of the Norfolk County Retirement System (the “System”) are seeking Requests for Proposal from investment management firms to manage part of the System’s defined benefit plan assets in a Small Cap Value Equity product. The System’s target allocation to small cap value equity is 5.1% and the total assets of the System were approximately \$1.3 billion as of June 30, 2023 according to the Plan’s custodian. While the precise dollar allocation for this assignment will be determined at the time of funding, we expect the allocation to be between \$55 and \$65 million. The Board will consider separately managed accounts and pooled funds, however, **mutual funds will not be considered.**
