**DECISION**

**LESVOS INC. D/B/A PROVO DISCOUNT LIQUORS**  
**282 DEDHAM ST**  
**NORFOLK, MA 02056**  
**LICENSE#: 081800005**

Lesvos Inc. d/b/a Provo Discount Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, November 1, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Keefe's Report.

The following documents are in evidence:

1. Investigator Keefe's Compliance Check Field Report dated May 17, 2016; and
2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

**FACTS**

1. On Tuesday, May 17, 2016, at approximately 8:00 p.m., Investigators Di Cicco and Keefe investigated the business operation Lesvos Inc. d/b/a Provo Discount Liquors.
2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a Corona Light beer for two dollars and seventy-five cents (\$2.75). The underage operative was not asked for identification.

### CONCLUSION


Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 10 years and has had no previous violations, the Commission issues a **WARNING**.
