### **DECISION**

Norfolk Wine & Spirits Inc. ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 16, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Cutter & Teehan's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Cutter & Teehan's Minimum Purchase Age Compliance Check Field Report;
- 2. ABCC Form 43, Transfer of License Approved, 1/31/2013;
- 3. ABCC Decision, 3/1/2022;
- 4. Licensee Stipulation of Facts.

#### **FINDINGS OF FACT**

- 1. On Wednesday, May 28, 2025, at approximately 5:08 p.m., Investigators Teehan & Cutter ("Investigators") conducted a compliance check at Norfolk Wine and Spirits Inc.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 6-pack of Bud Light beer for eight dollars and ninety-nine cents (\$8.99). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2013.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
