DECISION

SARTHI CONVENIENCE INC. D/B/A LIQUOR WORLD 10 ROCKWOOD ROAD NORFOLK, MA 02056

LICENSE#: 00007-PK-0818 VIOLATION DATE: 9/02/2022

Sarthi Convenience Inc. d/b/a Liquor World (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, December 6, 2022, regarding an alleged violation of M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one (21) years of age (1 Count). Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Quinn's Report.

- 1. Investigator Quinn's Violation Report;
- 2. ABCC Form 43, New All-Alcoholic Beverages License Approval, 2/11/2014;
- 3. ABCC Form 43, Transfer of Wines & Malt Beverages License Approval, 3/29/2007;
- 4. Photographs of Fraudulent Driver's License Confiscated;
- 5. Licensee Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Friday, September 2, 2022, Investigators Cutter, Keefe, and Quinn ("Investigators") inspected the business operation of Sarthi Convenience Inc. d/b/a Liquor World to determine the way its business was being conducted.
- 2. At approximately 6:25 p.m., while outside the establishment, Investigators observed one youthful appearing male individual enter the licensed premises. Investigator observed the same individual exit the store carrying a case of High Noon Hard Seltzer.
- 3. Investigators approached the individual, identified themselves and asked to see proof of legal age to purchase and/or possess alcoholic beverages.

- 4. Underage #1, actual date of birth 10/15/2004 (age 17), provided Investigators with a fraudulent Rhode Island driver's license in his own name with a different birth date, which he had used to purchase the alcoholic beverages. He also provided his true Massachusetts driver's license.
- 5. Investigators confiscated the case of High Noon Hard Seltzer and the fraudulent license.
- 6. At approximately 8:30 p.m., Investigators entered the licensed premises and spoke to the employees on duty. Investigators informed the employees of the violation and that a report would be filed with the Chief Investigator for review.
- 7. Mr. Nitante Raval, Principal of the Licensee corporation, appeared at the Commission hearing. The Commission was informed that Underage #1 had been asked to produce not only identification but also a back-up, as the Licensee's policy dictates. Underage #1 presented a credit card. Prior to this incident the Licensee had ordered a state-of-the-art identification scanner which is now in place.
- 8. The Licensee has held a license under M.G.L. c. 138, § 15 since 2007 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated M.G.L. Ch. 138, § 34 Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age (1 Count). Therefore, the Commission suspends the license for a period of one (1) day which will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations are found by this Commission.
