DECISION

MC CRACKENS LIQUORS & WINES INC. 531 CHICKERING RD NORTH ANDOVER, MA 01845

LICENSE#: 082600017

Mc Crackens Liquors & Wines Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, July 18, 2017, regarding an alleged violation of 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

- 1. Investigator Doyle's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.
- A. Letter, dated July 10, 2017, from North Andover Police Chief Charles Gray.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Monday, May 8, 2017, at approximately 7:26 p.m., Investigators Bailey and Doyle ("Investigators") investigated the business operation of Mc Crackens Liquors & Wines Inc.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a can of Bud Light beer, for three dollars (\$3.00). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 40 years with no prior violations, the Commission issues a **WARNING**.
