## **DECISION**

GC FRIDAY'S BOSTON LLC D/B/A TGI FRIDAYS 1385 SOUTH WASHINGTON ST. NORTH ATTLEBORO, MA 02760

LICENSE#: 0830-00045

**VIOLATION DATE: 06/19/2017 HEARING DATE: 10/10/2017** 

GC Friday's Boston Inc. d/b/a TGI Fridays (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, October 10, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Keefe's Report.

The following documents are in evidence:

- 1. Investigator Keefe's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.
- A. Licensee's Hearing Memorandum with Its Policies and Procedures for Safe Alcohol Service.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

## **FACTS**

- 1. On Monday, June 19, 2017, at approximately 5:12 p.m., Investigators Kujawski and Keefe ("Investigators") investigated the business operation of GC Friday's Boston LLC d/b/a TGI Fridays.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Bud Light beer, for four dollars and seventy cents (\$ 4.70). The underage operative was not asked for identification.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 15 years with no prior violations, the Commission issues a **WARNING**.
