**DECISION**

**SWAMINI ENTERPRISE INC. D/B/A BOB'S DELI & VARIETY**  
**39 GROVE STREET**

Swamini Enterprise Inc. d/b/a Bob's Deli & Variety ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, April 30, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Kujawski & Gould's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Kujawski & Gould's Minimum Purchase Age Compliance Check Field Report, 3/11/2024;
2. ABCC Licensing Authority Certification, Transfer of License;
3. Licensee's Stipulation of Facts.

**FINDINGS OF FACT**


1. On Monday, March 11, 2024, at approximately 5:20 p.m., Special Investigators Gould and Kujawski ("Investigators") conducted a compliance check at Swamini Enterprise Inc. d/b/a Bob's Deli & Variety.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 25-ounce container of Bud Light beer, for three dollars and fifty cents (\$3.50). The underage operative was not asked for identification.
3. The Licensee holds a license under M.G.L. c. 138, § 15 with no prior violations.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
