#### **DECISION**

Zhengs International Inc. d/b/a Greatwoods Mandarin ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, October 4, 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator David's Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigator David's Minimum Purchase Age Compliance Check Field Report;
- 2. ABCC Form 43, Transfer of License Approval, 10/2/2007;
- 3. Licensee's Stipulation of Facts.

# **FINDINGS OF FACT**

- 1. On Tuesday, June 14, 2022, at approximately 5:12 p.m., Investigators Smith and David ("Investigators"), inspected the business operation of Zhengs International Inc. d/b/a Greatwoods Mandarin.
- 2. An underage operative, working under the supervision of Investigators, was served an alcoholic beverage, one bottle of Bud Light beer. The underage operative was not asked for identification.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING.**
