Tsing, Inc. d/b/a Beijing House ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 14, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Watson and Teehan's Minimum Purchase Age Compliance Check Field Report.

The record was left open for the Licensee to submit additional exhibits. There is one (1) audio recording of this hearing.

FINDINGS OF FACT

1. On Tuesday, May 16, 2023, at approximately 5:48 p.m., Investigators Watson and Teehan's ("Investigators") conducted a compliance check at Tsing, Inc. d/b/a Beijing House.

2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one bottle of Bud Light beer, for four dollars and eighty cents (\$4.80). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 12 since 1993.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
