## **NOTICE: DPL Board of Public Accountancy Joins National Licensing Databases**

Effective June 18, 2013, the Board of Public Accountancy is participating in two national licensing databases, CPAverify and the Accountancy Licensing Database (ALD), maintained by the National Association of State Boards of Accountancy (NASBA). These databases will make more state licensing information available to the Board, licensees, and the public.

<u>CPAverify</u>: CPAverify is a free, online database that provides basic information regarding the status of Certified Public Accountants (CPAs) and accounting firms licensed to practice in participating jurisdictions. Specifically, CPAverify provides online reports to employers, professionals and the general public who wish to obtain licensing history information from a single-source national database. Boards of Accountancy in more than 40 states currently participate in CPAverify.

Accountancy Licensing Database (ALD): ALD is a free resource for state boards of accountancy. Through ALD, authorized board staff will now have consolidated online access to information regarding the licensure status and disciplinary history of out-of-state licensees practicing in Massachusetts. In exchange for access to this information, the Board will provide similar information to ALD on CPAs and accounting firms licensed to practice in Massachusetts. Boards of Accountancy in more than 44 states currently participate in the database.

The Board also ensures that licensees have complied with all continuing education and peer review report requirements necessary to renew their licenses. The Board currently licenses more than 18,000 individuals and businesses in the public accountancy profession.
