Notice is hereby given that the Massachusetts Department of Environmental Protection, acting in accordance with the provisions of Massachusetts General Laws, Chapter 30A, Section 2; Chapter 111, Sections 142A-142E and 310 CMR 7.00: Appendix C of the Air Pollution Control Regulations, will hold a public hearing on the following draft Operating Permit Renewal.

The draft renewal Operating Permit for Pittsfield Generating Company LP is being issued in accordance with 310 CMR 7.00: Appendix C(6). The purpose of the Operating Permit is to codify all of the facility's applicable requirements under the state and federal Clean Air Act, including monitoring, record keeping requirements and emission limitations, into a renewable Operating Permit.
