## VARIANCES

 PV-190 – University of Massachusetts - Goessman Hall – 686 North Pleasant Street – Amherst Applicant Peter Radzim of VAV International Inc. has a two part variance request.
1<sup>st</sup>: Renovation of floor 2 includes the addition of new handwashing sinks in renovated labs.

They are requesting permission to feed handwashing sinks with tempered water from a central tempered water loop and to pipe waste to the special (lab) waste system.  $2^{nd}$ : There are currently no separate staff bathrooms, they are requesting the installation of a

single user gender neutral ADA compliant bathroom on the second floor for staff.

#### PV-194 - Misty Amero Kindred Gardens Early Learning & Care - 5A. Dr. Osman Babson Rd -Gloucester

Applicant Misty Amero is seeking a variance from 248 CMR 10.10 (18) Table 1. There are currently 2 bathrooms in this daycare facility that serves 28 children. Included with this variance request was written documentation that the Gloucester Board of Health has been petitioned.
