PUBLIC HEARING NOTICE

The Massachusetts Department of Environmental Protection (MassDEP), acting in accordance with the provisions of M.G.L. c. 111, Sections 142A through 142O, and in conformance with 40 CFR 51.102, will hold two public hearings and a comment period on the proposed “Massachusetts Regional Haze State Implementation Plan Revision for the Second Implementation Period (2018-2028).”

Regional haze is caused by fine particle pollution that impairs visibility over a large region by scattering or absorbing light. The federal Clean Air Act, in sections 169A and 169B, contains requirements for the protection of visibility in 156 national parks, forests and wilderness areas that have been federally designated as Class I areas. In 1999, the U.S. Environmental Protection Agency (EPA) promulgated regional haze rules that require states to develop State Implementation Plans (SIP) every ten years to improve visibility in federal Class I areas, such as Acadia National Park in Maine. MassDEP issued its first Regional Haze SIP in 2012 for the 2008 – 2018 planning period. MassDEP’s proposed SIP revision is for the 2018 – 2028 planning period and documents how existing regulations, facility permits, and other actions meet EPA’s regional haze rule requirements. After public hearing and comment, MassDEP will submit the final Regional Haze SIP revision to EPA for approval into the Massachusetts SIP.

Per Governor Charles D. Baker’s Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, s. 20 signed and dated March 12, 2020, the public hearings will be conducted via remote video conference call and will be open to the public.
