NOTICE OF PUBLIC HEARING

Pursuant to M.G.L. c. 13, §§ 12A - 12C, M.G.L. c. 112, §§ 13 - 23, and M.G.L. c. 30A, the Division of Professional Licensure's (DPL) Board of Registration in Podiatry will hold a public hearing relative to the proposed promulgation of amendments to the Board's regulations, 249 Code Mass. The Board is proposing these changes in light of <u>Executive Order 562</u> and in response to public feedback received at a public listening session held pursuant to Executive Order 562 June 9, 2015. The proposed amendments will eliminate outdated and redundant language, reduce administrative burdens for limited licensees, and clarify reciprocity and reinstatement requirements. Interested parties will be given an opportunity to present testimony, orally or in writing, at the hearing.
