## NOTICE OF MEETING

The Board of Registration of Cosmetology and Barbering is considering changes to the Rules and Regulations governing the registration and conduct of Cosmetologists (including Aestheticians and Manicurists), Barbers, and Electrologists, 240 CMR 2.00-7.00, 232 CMR 2.01-2.02, and 238 CMR 2.00-4.00. The review of the regulations will be conducted pursuant to Executive Order 562 issued by Governor Baker on March 31, 2015.
