On December 9, 1998, the Department of Telecommunications and Energy ("Department") issued an Order instituting a rulemaking proceeding and promulgating proposed amendments to 220 C.M.R. §§ 45.00 et seq. to establish complaint and enforcement procedures to ensure that telecommunications carriers and cable system operators have non-discriminatory access to utility poles, ducts, conduits, and rights-of-way on rates, terms and conditions that are just and reasonable. The matter has been docketed as D.T.E. 98-36.

The Department published notice of its proposed rulemaking in the *Massachusetts Register* no. 859, on December 25, 1998. As a result, the Department received written and oral comments stating, *inter alia*, that the final rules should provide competitive telecommunications and cable companies with nondiscriminatory access to poles, ducts, conduits, and rights-of-way inside and on commercial and residential buildings.
