Approval of Physician Assistant Training Programs

Discussion of existing statutory and regulatory requirements

After a discussion of existing statutory and regulatory requirements governing Massachusetts physician assistant training programs, the Board determined that a letter of acknowledgement be sent to established physician assistant training programs in Massachusetts that are accredited by the Accreditation Review Commission for the Physician Assistant (ARC-PA); that new programs notify the Board by letter when ARC-PA accreditation is received and when the program's accreditation status is changed; and that the Board's website be updated with the inclusion of this information. Board staff will draft a letter for Board review at the December meeting.

B. Update: Proposed Regulatory Amendments at 263 CMR 5.04(3)(b) and 5.08:

Physician Assistants Authorized to Operate Fluoroscopic X-ray Systems and Perform

Ms. Stein informed the Board that final approval of the proposed amendments at 263 CMR 5.00 governing PAs' performance of fluoroscopic procedures was requested in September 2012 and she is waiting for approval to file final regulations. She will continue to monitor the progress of the request.

C. Update: Proposed Regulatory Amendment at 263 CMR 5.05(2): Scope of Supervision Required
Status of proposed regulatory amendment

Ms. Stein reported that the request for the approval to promulgate an emergency regulation repealing the Board's regulation at 263 CMR 5.05(2) governing the number of physician assistants who may be supervised by a physician was submitted for DHPL review. The repeal is necessary so as to comply with Section 111 of Chapter 224 of the Acts of 2012, which amended M.G.L. c. 112, s. 9E and was effective on November 4, 2012. Board staff will post the statutory amendment on the Board's website, along with applications and forms reflecting the change.
