Honorable Chairs and Ranking Minority Members of the Committees on Ways and Means:

Pursuant to Section 6 of Chapter 14 of the General Laws¹, the Department of Revenue (DOR) hereby submits its mid-month tax revenue report for the month of November 2022, the fifth month of fiscal year 2023. The attached table shows November 2022 month-to-date tax revenue collections through November 15, 2022, along with changes from the equivalent period in November 2021.

Revenue collections are uneven and usually weighted toward month-end. The brief period covered in the mid-month report does not provide sufficient data for comparison to prior years. Therefore, mid-month figures should not be used to assess trends or project future revenues.

Context for November Revenues

In general, November is among the smaller months for revenue collection because neither individual nor business taxpayers make significant estimated payments during the month. Historically, roughly 6.5% of annual revenue, on average, has been received during November.

Highlights

Total Tax collections for the month-to-date period were \$886 million, down \$215 million or 19.5% versus the same period in November 2021. The month-to-date decrease is mostly due to decreases in withholding, sales tax, and all other tax coupled with an unfavorable increase in income tax refunds, partially offset by increases in corporate and business tax and income estimated payments. Month-to-date declines in withholding and sales tax were expected and resulted from typical periodic variations in the timing of collections.

- **Income Taxes** totaled \$632 million, down \$162 million or 20.4% versus the same period in November 2021.
- Sales & Use Taxes totaled \$128 million, down \$34 million or 21.1% versus the same period in November 2021.
- **Corporate & Business Taxes** totaled \$52 million, up \$15 million or 38.9% versus the same period in November 2021.
- Other Taxes totaled \$74 million, down \$33 million or 30.7% versus the same period in November 2021.

Details

Total Income Tax of \$632 million for mid-month November is comprised of the following:

- Withholding of \$623 million, down \$151 million versus the same period in November 2021.
- Estimated Payments of \$36 million, up \$15 million versus the same period in November 2021.
- **Returns/Bills** of \$35 million, up \$3 million versus the same period in November 2021.
- **Refunds** of \$63 million, up \$30 million (unfavorable) versus the same period in November 2021.

Sales & Use Tax of \$128 million, down \$34 million versus the same period in November 2021. Typically, only a small proportion of expected regular sales and meals tax remittances is received by the mid-month date. The month-to-date sales and use tax of \$128 million is comprised of the following:

- **Regular sales** tax of \$53 million, down \$27 million versus the same period in November 2021.
- Meals tax of \$31 million, down \$10 million versus the same period in November 2021.
- Motor vehicle sales tax of \$45 million, up \$3 million versus the same period in November 2021.

Corporate & Business Tax of \$52 million, up \$15 million versus the same period in November 2021. The month-to-date increase mostly reflects an increase in corporate and business estimated payments, partially offset by an unfavorable increase in refunds.

Other Taxes of \$74 million, down \$33 million versus the same period in November 2021, includes a number of tax categories such as motor fuels, cigarettes, estate taxes, room occupancy, deeds, and others.
