The Massachusetts Department of Correction (DOC) frequently offers voluntary, mobile COVID-19 testing to staff. Testing locations vary to allow staff working in all regions, a convenient test location.¹ This report is based on a culmination of data collected from the mobile testing sites and information self-reported by staff² as of November 30, 2020.

For staff testing at mobile testing sites, there were zero new positive COVID-19 test results self-reported by staff as of November 30, 2020.

¹ Staff counts are based on Massachusetts Department of Correction Mobile testing site location/ date of test and results self-reported by Massachusetts Department of Correction staff.

² There may be duplicate case counts due to staff self-reporting results from mobile testing and private physician/testing sites.
