HEARING DECISION

This matter is before the Building Official Certification Committee ("Committee") as a result of a Complaint filed by Don Fitzgerald, Building Commissioner for the Town of Adams, against his predecessor, David Pelletier. The Complaint was referred to the Committee for a hearing by the Administrator of the Board of Building Regulations and Standards ("BBRS") in accordance with 780 CMR 110.R7.4.1.1. In his Complaint, Commissioner Fitzgerald alleged that Mr. Pelletier secretively issued a Certificate of Use and Occupancy ("CO") while no longer in office, in violation of 780 CMR 110.R74.1.5(3) (fraudulent or deceitful practice as a certified building official) and (4) (gross negligence or misconduct in the performance of building official duties).

A hearing was held on November 5, 2014, at the Center Office Building in the Town of Sturbridge, MA.¹ Mr. Pelletier and Commissioner Fitzgerald were the only witnesses, both of whom were duly sworn prior to testifying.

Findings of Fact

The following findings of fact are supported by substantial evidence based upon review of the exhibits marked at the hearing as well as the Complaint² and credible testimony. The relevant facts are as follows:

¹ The hearing was originally scheduled to be held at the Sturbridge Public Safety Building, but had to be moved to the Central Office Building on the day of the hearing due to a booking error. All parties were immediately notified of the change and were able to attend.

- 1. Don Fitzgerald held the office of Building Commissioner for the Town of Adams as of January 27, 2014. (Testimony of Commissioner Fitzgerald, Exhibit 3)
- David Pelletier resigned his position as Building Commissioner for the Town of Adams on or about December 13, 2014, and, as of January 27, 2014, he was not legally authorized to issue certificates of use and occupancy in the Town of Adams. (Testimony of Commissioner Fitzgerald, Complaint, Exhibit 3)
- 3. On or about February 19, 2014, David Pelletier and Pamela Gerry, administrative assistant to the Town of Adams Building Commissioner, made a plan for Mr. Pelletier to issue a CO for 64 Summer St. in the Town of Adams by discussing the details of the CO and arranging to meet after normal business hours. The meeting coincided with a social engagement between Mr. Pelletier and Ms. Gerry, and was not within the Building Commissioner's Office at Town hall. Neither Mr. Pelletier nor Ms. Gerry notified Commissioner Fitzgerald of their plan. (Testimony of Commissioner Fitzgerald and David Pelletier, Exhibits 2a and 2b)
- 4. On February 21, 2014, David Pelletier did sign and issue a CO for 64 Summer St. in the Town of Adams. (Testimony of Commissioner Fitzgerald and David Pelletier, Exhibit 1)
- 5. Commissioner Fitzgerald was completely unaware that a CO had issued for 64 Summer St. in the Town of Adams until he discovered the CO, signed by David Pelletier, in his office files on or about February 27, 2014. (Testimony of Commissioner Fitzgerald, Complaint)
- 6. Shortly after discovering the CO for 64 Summer St., Commissioner Fitzgerald rescinded the CO because it was unauthorized and building code violations at the subject property precluded full occupancy. (Testimony of Commissioner Fitzgerald)

Discussion

The Building Official Certification Committee was established by the BBRS in accordance with 780 CMR 110.R7.1.5.1. One of the Committee's primary responsibilities is to review the credentials of applicants for certification as a building official in accordance with M.G.L. c.143, §3. See 780 CMR 110.R7.1.5.2. The Committee is also importantly charged with hearing complaints against certified building officials and recommending disciplinary action to the BBRS pursuant to 780 CMR 110.R7.1.4.3 and 110.R7.4.1.4. Grounds for disciplinary action are found at 110.R7.4.1.5, and the following two grounds from that section are at issue in this case:

- (3) The holder has fraudulently or deceitfully practiced as a certified building official;
- (4) The holder has been grossly negligent or has engaged in misconduct in the performance of any of his or her duties

The evidence overwhelmingly established that Mr. Pelletier fraudulently and deceitfully practiced as a certified building official and engaged in misconduct with respect to the duties of a certified building official. Mr. Pelletier did not dispute Commissioner Fitzgerald's testimony or the exhibits provided, and he admitted to having issued the CO for 64 Summer St. after he was no longer in office. He explained his actions as a matter of poor judgment and admitted that they were wrong. Mr. Pelletier also testified that there was some confusion as to when exactly he was no longer authorized to act as a building official for the Town of Adams, but the evidence clearly established that he knew he no longer had that authority as of February 19, 2014, at which time he was planning to meet Pamela Gerry to issue the CO. The Committee believes that arranging for a clandestine meeting with a former staff member in order to issue a CO without the knowledge of one's successor to office is more than a matter of poor judgment. Instead, such actions clearly indicate deceit and misconduct, and they must not be taken lightly. To make matters worse, the evidence established that the property at issue should

not have been issued a CO in light of potentially serious building code violations³, and, in fact, Commissioner Fitzgerald would not re-issue a CO for full occupancy after rescinding the unauthorized CO. Had Mr. Pelletier's clandestine actions gone undiscovered, public safety may well have been seriously jeopardized.

Conclusion and Order

By unanimous vote, Mr. Pelletier's Inspector of Buildings/Building Commissioner Certification is hereby **REVOKED** as a result of the violations found within, and, further, such conduct renders Mr. Pelletier unfit to serve as an inspector of buildings in any capacity pursuant to M.G.L. c.143, §3.
