FINAL DECISION

I have reviewed the attached Administrative Consent Order with Penalty and Notice of Noncompliance signed on May 17, 2021 by David Cutler, Manager of NS Holdings LLC, and on May 26, 2021 by Eric Worrall, Regional Director for the Department (ACOP #00011268).

The Department issues this Final Decision incorporating the Administrative Consent Order with Penalty. The Petitioner is ordered to pay a civil administrative penalty of forty-four thousand and five hundred dollars (\$44,500) with a suspended amount of (\$24,500) contingent upon the petitioner's compliance with the terms of the settlement agreement and in accordance with paragraphs 13 and 20 of the Administrative Consent Order. Under the terms of 310 CMR 1.01(8)(c), this proceeding is dismissed with the parties waiving whatever rights they may have to further administrative review before the Department as well as any appeal to court.
