## **FINAL DECISION**

I am the Final Decision-Maker in this appeal by special designation.

The Conservation Law Foundation (“CLF”) and a Ten Residents Group comprised of 17 East Boston residents (collectively “the Petitioners”) filed this appeal challenging a Draft Waterways License (“the Draft License”) that the Boston Office of the Massachusetts Department of Environmental Protection (“MassDEP” or “the Department”) issued to NSTAR Electric d/b/a Eversource Energy (“the Applicant”) on January 3, 2022, pursuant to G.L. c. 91 (“Chapter 91”) and the Chapter 91 Regulations at 310 CMR 9.00. The Draft License authorized the Applicant’s proposed construction of an electric substation (“the proposed Project”) on real property located on Lot 2, 338 Eagle Street and Condor Street in East Boston (“the Site”).

On January 12, 2023, the Parties in this appeal: (1) the Petitioners, (2) the Applicant, and (3) MassDEP filed a Stipulation of Dismissal of this appeal *without prejudice*. This Stipulation of Dismissal constitutes the Petitioners’ voluntary withdrawal without prejudice of this appeal

with the Applicant's and MassDEP's assent. Accordingly, the Department issues this final decision incorporating the Stipulation of Dismissal and dismisses this appeal without prejudice.
