T P Panacy, LLC dba Bass & Blues Sandbar & Grille (the "Licensee") holds an all alcoholic beverages license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, April 10, 2012, regarding alleged violations of M. G. L. c.138, §34 (1 count). Prior to the commencement of the hearing the licensee stipulated to the violation alleged in Investigator Mark Kenny's Investigative Report.

## **FACTS**

- 1. On Friday, August 12, 2011, at approximately 11:00 p. m., Investigators Dennis Keefe, Jan Kujawski, and Mark Kenny, investigated the business operation of T P Panacy, LLC dba Bass & Blues Sandbar & Grille to determine the manner in which their business was being conducted.
- 2. Investigators entered the licensed premises and observed youthful looking patrons in possession
- 3. Investigators approached the youthful looking patrons and asked for proof of age.
- 4. A male individual produced a valid identification, but investigators observed that the picture on the id provided was not that of the individual standing in front of them.
- 5. The male individual was later identified as Mike Fitzgerald, of 18 Garden Terrace, Amherst, date of birth October 5, 1990, age twenty (20) years old.
- 6. Mr. Fitzgerald provided investigators with a Connecticut driver's license that was not him.
- 7. Mr. Fitzgerald stated that he was not twenty-one (21) years old.
- 8. Investigators identified themselves to the manager on duty, Troy, and informed him of the violation, and that a report would be submitted to the Chief Investigator for review.
