Topside Inc. dba The Ritz Cafe (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, July 8, 2014, regarding an alleged violation of M.G.L. c. 138 §69-Sale or Delivery of an Alcoholic Beverage to an Intoxicated Person (1 count).

By decision dated July 19, 2014, the Commission found the licensee in violation of the charge and suspended the license for thirty (30) days to be served. No offer in compromise will be considered for this penalty.

By letter dated July 21, 2014, the counsel for the Licensee requested a hearing to reconsider the thirty day suspension. On Wednesday, August 6, 2014, a hearing for the motion for reconsideration was held.

Topside Inc. dba The Ritz Cafe (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, July 8, 2014, regarding an alleged violation of M.G.L. c. 138 §69-Sale or Delivery of an Alcoholic Beverage to an Intoxicated Person (1 count). Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Velez's Report.

The following documents are in evidence:

1. Licensee's Stipulation of Facts; and

Investigator Velez's Violation Report dated June 13, 2014.

There is one (1) audio recording of this hearing.

<u>FACTS</u>

- 1. On Friday, June 13, 2014, at approximately 8:00 p. m., Investigators Binienda, Kenny, Keefe, and Velez conducted an investigation of the business operation of Topside Inc. dba The Ritz Cafe, to determine the manner in which its business was being conducted.
- 2. Investigator Velez entered the licensed premises at approximately 8:03 p.m., and observed an individual, Bobby King, who appeared to be intoxicated.
- 3. At approximately 8:09 p.m., Investigator Velez observed Mr. King speaking to a woman sitting at the bar.
- 4. Investigator Velez observed Mr. King spoke in an incoherent manner, and that he had red, bloodshot, glassy, and watery eyes.
- 5. At approximately 8:38 p.m., Investigator Velez observed that Mr. King was unsteady on his feet as he walked to the bathroom.
- 6. Investigator Velez also observed that Mr. King spoke to the bartender on duty in a thick and slurred speech.
- 7. Based on his training and experience, Investigator Velez formed the opinion that Mr. King was intoxicated.

- 8. At approximately 8:41 p.m., Investigator Velez observed Mr. King order a bottle of Miller Lite beer, and he observed the bartender on duty deliver the beer to Mr. King. Mr. King then grabbed the beer from the bar and consumed it.
- 9. Investigator Velez exited the premises, and Investigators Binienda, Kenny, and Keefe entered the premises and spoke to the owner, Janette King.
- 10. Ms. King stated to investigators that she instructed the bartender on duty to shut "Bobby" off.
- 11. The bartender on duty stated to Ms. King that Bobby had nagged her, and said it was his last drink, so she served him.
- 12. Ms. King stated that she would call a taxicab for Mr. King.
- 13. Investigators informed Ms. King of the violation and that a report would be filed with the Chief Investigator for further action.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated M.G.L. c. 138 §69-Sale or Delivery of an Alcoholic Beverage to an Intoxicated Person (1 count). Therefore, the Commission suspends the license for thirty (30) days to be served. No offer in compromise will be considered for this penalty.
