DECISION

KATHY HENDERSON-POE D/B/A RT. 148 PACKAGE STORE 479 NORTH BROOKFIELD RD. OAKHAM, MA 01068 LICENSE#: 89104-PK-0920

VIOLATION DATE: 4/1/2019 HEARING DATE: 6/11/2019

Kathy Henderson-Poe d/b/a Rt. 148 Package Store (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 11, 2019, regarding an alleged violation of 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Binienda's Report.

The following documents are in evidence:

- 1. Investigator Binienda's Compliance Check Field Report;
- 2. Licensee's Stipulation of Facts; and
- 3. Licensee's Application Summary Review.

There is one (1) audio recording of this hearing.

FACTS

- 1. On Monday, April 1, 2019, at approximately 6:24 p.m., Investigators Velez and Binienda ("Investigators") investigated the business of Kathy Henderson-Poe d/b/a Rt. 148 Package Store.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 6-pack of Bud Light beer, for eight dollars and twenty-one cents (\$8.21). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for one (1) day which will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
