DISCUSSION:

S. Waite summarized her previously distributed memorandum and attached exhibits to the Board. D. Drew asked S. Waite when the Accelerated Entry Master of Science in Nursing Degree Program (Accelerated Entry MSN Degree Program) was approved. In response to D. Drew, S. Waite stated it was approved at the 7/14/2021 Board of Registration in Nursing Board Meeting. In response to M. McMahon, D. Drew stated the program administrator needs to be strong, and asked why M. McMahon would be the program administrator for the Accelerated Entry MSN Degree Program. In response to D. Drew, L. Kelly stated that M. McMahon has mapped out the process and the plan, and the Accelerated Entry MSN Degree Program has what D. Drew is asking. C. MacDonald stated the College's Nursing Program has two (2) program administrators, it needs to have a program administrator in place for the Accelerated Entry MSN Degree Program during the 11 months, and asked M. McMahon why she could not appoint a program administrator now for the Accelerated Entry MSN Degree Program, and a program administrator for the traditional Master of Science in Nursing Degree Program (MSN Degree Program).
