Honorable Chairs and Ranking Minority Members of the Committees on Ways and Means:

Pursuant to Section 6 of Chapter 14 of the General Laws<sup>1</sup>, the Department of Revenue (DOR) hereby submits its mid-month tax revenue report for the month of October 2022, the fourth month of fiscal year 2023. The attached table shows October 2022 month-to-date tax revenue collections through October 14, 2022, along with changes from the equivalent period in October 2021.

Revenue collections are uneven and usually weighted toward month-end, and the brief period covered in the mid-month report does not provide sufficient data for comparison to prior years. Therefore, mid-month figures should not be used to assess trends or project future revenues.

### **Context for October Revenues**

In general, October is among the lower months for revenue collection, because neither individual nor business taxpayers make significant estimated payments during the month. Historically, roughly 6.5% of annual revenue, on average, has been received during October.

## **Highlights**

Total Tax collections for the month-to-date period were \$924 million, up \$45 million or 5.1% versus the same period in October 2021. The month-to-date increase is mostly due to increases in withholding, income return payments, and sales tax, partially offset by decreases in corporate and business tax and all other taxes coupled with unfavorable increase in income tax refunds.

- **Income Taxes** totaled \$711 million, up \$68 million or 10.7% versus the same period in October 2021.
- Sales & Use Taxes totaled \$134 million, up \$30 million or 28.9% versus the same period in October 2021.
- Corporate & Business Taxes totaled \$1 million, down \$15 million or 95.4% versus the same period in October 2021.
- Other Taxes totaled \$78 million, down \$39 million or 33.4% versus the same period in October 2021.

### **Details**

**Total Income Tax** of \$711 million for mid-month October is comprised of the following:

- **Withholding** of \$669 million, up \$81 million versus the same period in October 2021.
- Estimated Payments of \$32 million, down \$2 million versus the same period in October 2021.
- Returns/Bills of \$84 million, up \$28 million versus the same period in October 2021.
- **Refunds** of \$74 million, up \$37 million (unfavorable) versus the same period in October 2021.

**Sales & Use Tax** of \$134 million, up \$30 million versus the same period in October 2021. Typically, only a small proportion of expected regular sales and meals tax remittances is received by the mid-month date. The month-to-date sales and use tax of \$134 million is comprised of the following:

- Regular sales tax of \$67 million, up \$26 million versus the same period in October 2021.
- Meals tax of \$28 million, up \$8 million versus the same period in October 2021.

• **Motor vehicle** sales tax of \$39 million, down \$5 million versus the same period in October 2021.

**Corporate & Business Tax** of \$1 million, down \$15 million versus the same period in October 2021. The month-to-date decrease mostly reflects unfavorable increase in refunds, partially offset by increases in corporate and business estimated and return payments.

Other Taxes of \$78 million, down \$39 million versus the same period in October 2021, includes a number of tax categories such as motor fuels, cigarettes, estate taxes, room occupancy, deeds, and others.
