# Proposed working groups

## State and municipal procurement

From the initial assessment:

EEA and DOER will work with other agencies (e.g., Operational Services Division (OSD), MassDEP, the Department of Capital Asset Management and Maintenance (DCAMM), the Massachusetts Clean Energy Center (MassCEC), MassDOT, and the MBTA) and cities and towns responsible for procuring EVSE to coordinate procurement processes, and, if necessary, develop recommendations for the legislature to align processes. The EVICC will collaborate with **state fleet operators** to collect data to determine the highest priority locations for electric vehicle charging at state facilities and direct resources to facilitate charging installations at those locations.

## Curbside charging
