# **KEY ACCOMPLISHMENTS**

The Office would like to share with you a few items that have been reviewed, including:

- ✓ Masking is voluntary: For most of the time, in most places, masking is now voluntary. In all healthcare areas, masking will continue to be mandatory. At times, when there are clusters of COVID-19 outbreaks, masking will need to be mandatory during isolation and quarantine periods.
- ✓ DOC Corrections facilities have isolated outbreaks: Recently MCI Framingham, MCI Cedar Junction, SBCC, MTC, and OCCC have had COVID-19 infections. This is really not surprising as COVID-19 infections are still in all Massachusetts communities. Everyone has done an excellent job responding to the process of isolation and quarantine to keep the outbreaks to a limited number.
- ✓ Communication: The Office is working on this every day! We now have the website, email, and phone number. We would love to hear from DOC staff regarding concerns and questions about COVID-19 and the post-pandemic world.
- ✓ Feedback: We would love to hear from the DOC staff and leaders as we move toward a post-pandemic normal.
- ✓ Visitation: Masking in the visiting area will continue for now and be re-evaluated on August 1<sup>st</sup>. The reason is to limit infection risk from the visitors. Testing continues but we are adding the additional layer of protection for now as we have just recently allowed masks to be discontinued for staff and inmates.
