

**ONE COMMUNICATIONS' PETITION TO INTERVENE
AND NOTICE OF APPEARANCE**

Choice One Communications of Massachusetts Inc., Conversent Communications of Massachusetts, Inc., CTC Communications Corp., and Lightship Telecom, LLC, all of which do business as One Communications, petition to intervene in this proceeding.

In support of this petition, One Communications says:

1. Each of the One Communications operating companies named above is a competitive local exchange carrier ("CLEC") that is authorized to and does provide local exchange and exchange access services in Massachusetts.

2. The DTC opened this docket to consider the level of confidential protection that will be provided to the customer specific pricing ("CSP") contracts entered into by Verizon Massachusetts. Pursuant to 47 U.S.C. § 251(c)(4), Verizon must make CSP contracts available for resale by CLECs.

3. One Communications' interests will be substantially and specifically affected by the issues under investigation in this docket. In particular, because One Communications is permitted under federal law to resell any of Verizon's CSP contracts, any changes to the availability of those contracts will have an impact on One Communications.


4. One Communications' interests cannot be adequately represented by any other party. Consequently, One Communications' participation in this proceeding will help ensure the development of a comprehensive record, while affording One Communications the opportunity to protect its interests.

5. If allowed to intervene, One Communications expects to participate in this proceeding by performing some or all of the following: conducting discovery, providing evidence, conducting cross examination, and filing briefs and comments.
