Meeting called to order:

Report from Executive Director:

• MassHealth Participation: Associate Executive Director Burke reported that the majority of Optometry licensees not registered as a billing or non-billing provider with MassHealth resides out of state. He will provide a list of Optometry licensees not in compliance following current renewal period. Non-compliance may affect providers' care of patients.

Discussion:

Emergency policy for reciprocal and reinstated licenses – the Board reviewed changes to
proposed policy for improvement of the reinstatement and reciprocal/endorsement licensing
processes. After discussion, Dr. Rakusin moved to approve policy. Dr. Sewell seconded.

- Review of Current Regulations, 246 Code Mass. Regs the Board instructed Counsel to report on changes to distance learning requirements and report to the Board at a future meeting.
- Implementation of addition of Glaucoma treatment to the Optometrist scope of practice legislation signed on January 1, 2021 to permit Massachusetts Optometrists to provide treatment of glaucoma. The Board discussed criteria for certification –both clinical and didactic training and expressed an interest in working with the Department of Public Health ("DPH") on content and regulatory process. Attorney Romeo-Porcaro proposed a meeting to discuss the following topics on February 17, 2021 at 10:00 am: reciprocity, educational components, residency and implantation.
