ORDER TO SHOW CAUSE

- 1. The State Ethics Commission ("Commission") is authorized by G.L. c. 268B to enforce G.L. c. 268A, the state conflict of interest law, and in that regard, to initiate and conduct adjudicatory proceedings.
- 2. On April 9, 2020, the Commission (a) found reasonable cause to believe that Christopher Hicks violated G.L. c. 268A, §§ 27 and 28 and (b) authorized the initiation of adjudicatory proceedings.

FACTS

- 3. In May 2018, Christopher Hicks ("Hicks") was elected to the Town of Berkley Planning Board.
- 4. As a Berkley Planning Board member, Hicks was municipal employee and subject to G.L. c. 268A.
- 5. General Laws chapter 268A, § 27, requires every municipal employee, within 30 days of becoming such an employee, and on an annual basis thereafter, to receive a summary of G.L. c. 268A and to sign a written acknowledgment that he has been provided with such a summary.

- 6. General Laws chapter 268A, § 28, requires every municipal employee, within 30 days after becoming such an employee, and every 2 years thereafter, to complete the Commission's conflict of interest law online training program.
- 7. At his swearing-in as a Planning Board member, the Berkley Town Clerk provided Hicks with a packet of materials, including the summary of the conflict of interest law. The Town Clerk notified Hicks that he was required to take the Commission's conflict of interest law online training program and acknowledge his receipt of the summary of the conflict of interest law.
- 8. Hicks did not take the Commission's conflict of interest law online training program after being advised by the Town Clerk of the statutory requirement.
- 9. Hicks did not acknowledge receipt of the summary of the conflict of interest law after being advised by the Town Clerk of the statutory requirement.
- 10. In June, August and October 2019, the Commission's Public Education

 Division repeatedly sought Hicks' compliance with the statutory requirements to take the

 Commission's conflict of interest law online training program and to acknowledge his

 receipt of the summary of the conflict of interest law.
- 11. To date, Hicks has failed to acknowledge his receipt of the summary of the conflict of interest law.
- 12. By failing to acknowledge his receipt of the summary of the conflict of interest law, Hicks violated § 27.
- 13. To date, Hicks has failed to complete the Commission's conflict of interest law online training program.

14. By failing to complete the Commission's conflict of interest law online training program, Hicks violated § 28.

WHEREFORE, Petitioner asks that the Commission:

- 1. find that Christopher Hicks violated G.L. c. 268A, §§ 27 and 28; and
- 2. levy such fines, issue such orders and grant such other relief as may be appropriate.
