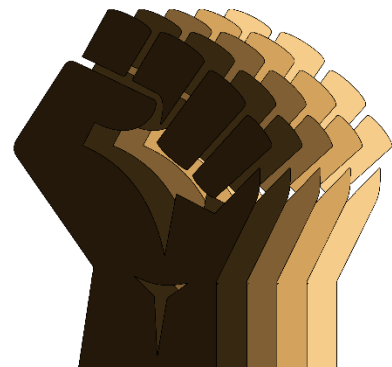
"May this be the day

The AGO Honors Black Lives [Spring 2020]

The AGO held three “Open and Honest Conversations” led by **Chief of Organization Development & Inclusion April English**, MFD **Managing Attorney Greg Matthews**, and former colleagues from the Office, in support of our Black community. The discussions began in response to the murder of George Floyd, systemic racism, and supporting the Black Lives Matter Movement. The first conversation was held on *May 28, 2020*, the second on *June 4, 2020*, and the third on *July 2, 2020*.



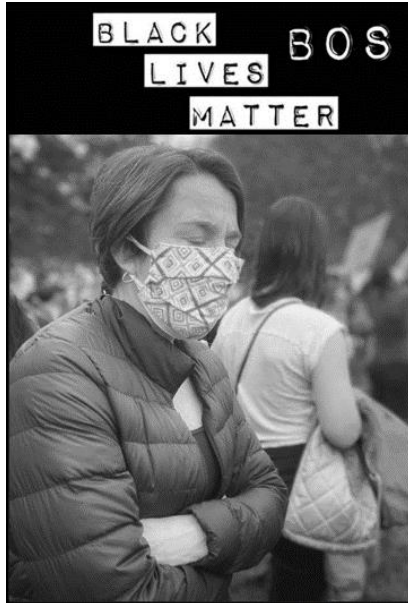

The AGO Supports Black Lives [Spring 2020]



AG Healey marched in Franklin Park with colleagues to support Black Lives Matter.

On *June 2, 2020*, **AG Healey** spoke before the Greater Boston Chamber of Commerce at the **Government Affairs Forum** about the work we've done as an office, and our partnership with the business community to make positive change. In addition, AG Healey discussed the disparities against Black and Brown people, the killing of George Floyd, addressing systemic racism, and the responsibility of white people to do more. 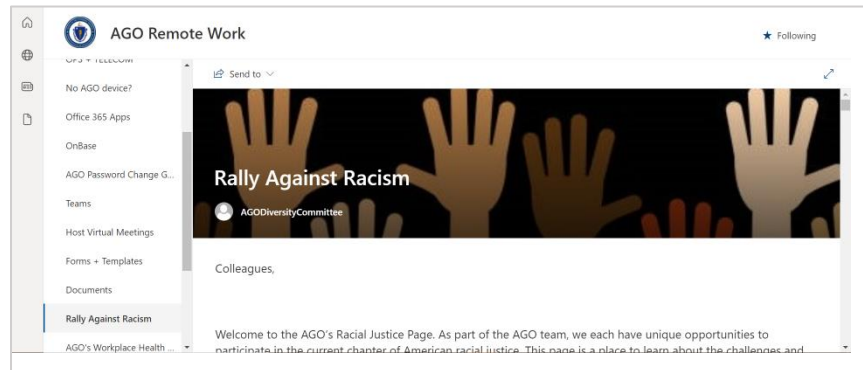

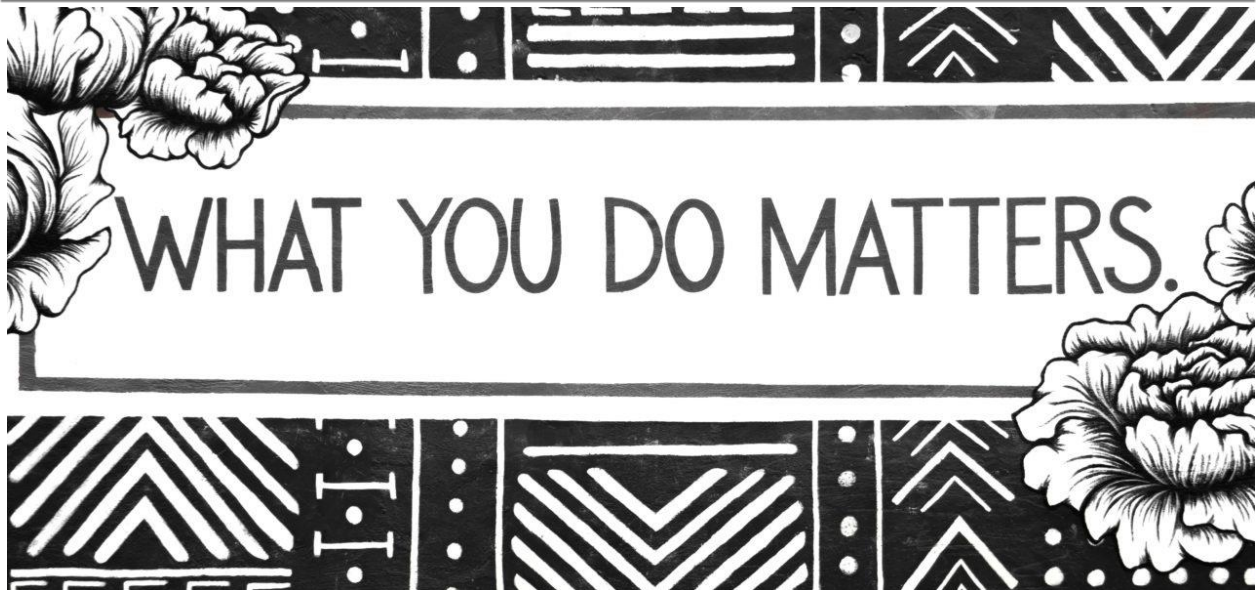

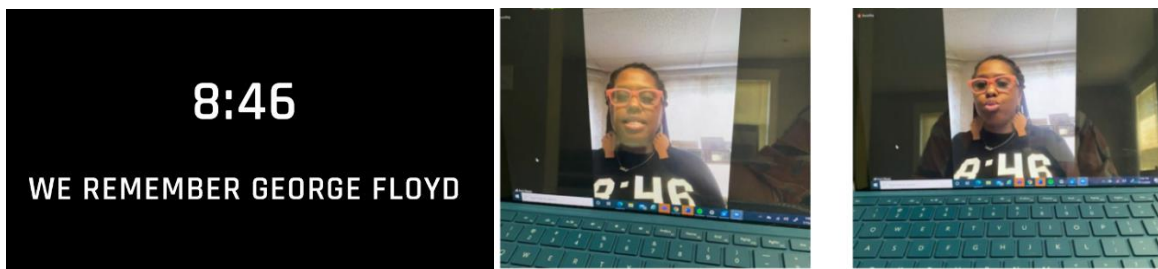

Organization Development & Inclusion Events [Summer 2020]



On *July 15, 2020*, Chief of Organization Development & Inclusion April English presented on “How to be a Helpful Ally in the Fight for Diversity, Equity, and Inclusion” at Sullivan Worcester Law Firm to over 100 staff and partners in the Massachusetts and New York offices. The AGO Reflects on the Life and Legacy of Congressman John Robert Lewis #RestInPower [Summer 2020]

On July 17, 2020, we lost civil rights leader and activist, Congressman John Robert Lewis, who was honored by the Office and featured in the AGO Weekly Roundup. As he was dying, Congressman Lewis wrote one final, beautiful essay. See a passage from the essay below, and view the full essay, [here](#).



"While my time here has now come to an end, I want you to know that in the last days and hours of my life you inspired me. You filled me with hope about the next chapter of the great American story when you used your power to make a difference in our society. Millions of people motivated simply by human compassion laid down the burdens of division. Around the country and the world you set aside race, class, age, language and nationality to demand respect for human dignity.

That is why I had to visit Black Lives Matter Plaza in Washington, though I was admitted to the hospital the following day. I just had to see and feel it for myself that, after many years of silent witness, the truth is still marching on.

Emmett Till was my George Floyd. He was my Rayshard Brooks, Sandra Bland and Breonna Taylor. He was 14 when he was killed, and I was only 15 years old at the time. I will never ever forget the moment when it became so clear that he could easily have been me. In those days, fear constrained us like an imaginary prison, and troubling thoughts of potential brutality committed for no understandable reason were the bars.

Though I was surrounded by two loving parents, plenty of brothers, sisters and cousins, their love could not protect me from the unholy oppression waiting just outside that family circle. Unchecked, unrestrained violence and government-sanctioned terror had the power to turn a simple stroll to the store for some Skittles or an innocent morning jog down a lonesome country road into a nightmare. If we are to survive as one unified nation, we must discover what so readily takes root in our hearts that could rob Mother Emanuel Church in South Carolina of her brightest and best, shoot unwitting concertgoers in Las Vegas and choke to death the hopes and dreams of a gifted violinist like Elijah McClain."

In *August of 2020*, the **Diversity, Equity, and Inclusion Committee** recognized the month as Black August. Throughout the month the Committee also promoted local Black-owned business to support. Additionally, the Committee recognized the 55th anniversary of the Voting Rights Act, and the 57th anniversary of Dr. Martin Luther King Jr.'s 'I Have a Dream' Speech. Also recognized was Jacob Blake, who was paralyzed after being shot by police in Kenosha, Wisconsin.

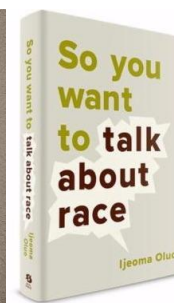

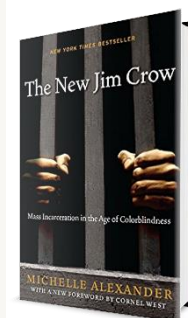
The AGO Honors the Legacy of Dr. Martin Luther King Jr. [Winter 2021]

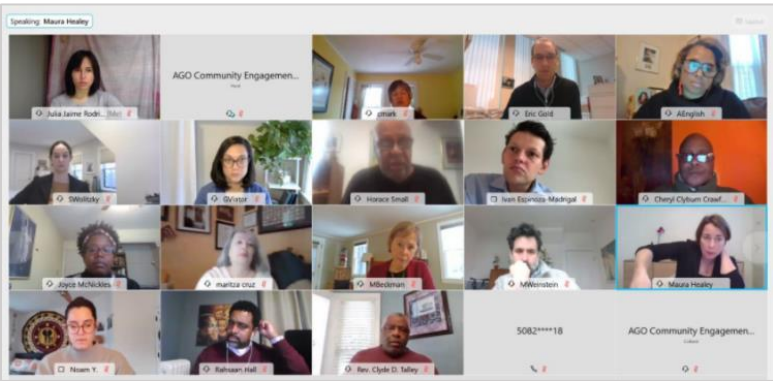

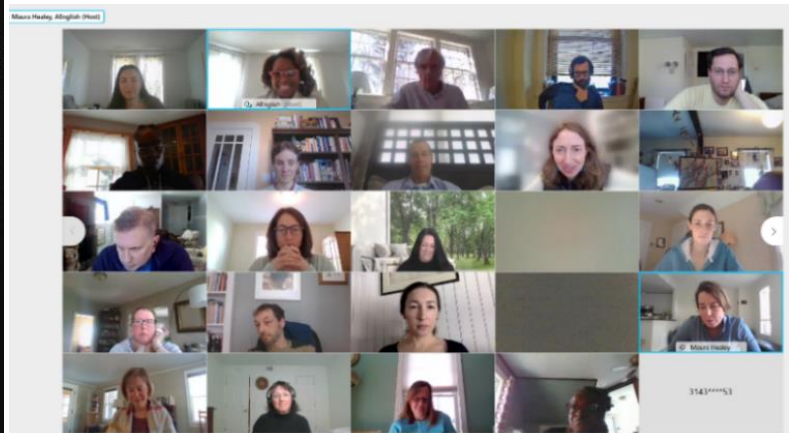
Black History Month Continued [Winter 2021]



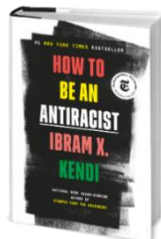

HERstory

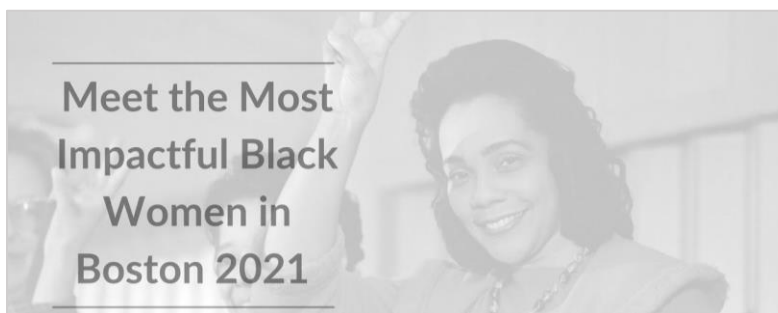
“HERstory” is a term for history written from a feminist perspective and emphasizing the role of women or told from a woman's point of view. It originated as an alteration of the word “history,” as part of a feminist critique of conventional historiography, which is traditionally written as “his story,” i.e., from the male point of view. The principle aim of herstory is to bring women out of obscurity from the historical record.”



For Women’s History Month, or HERstory Month, the **Diversity, Equity, and Inclusion Committee** sent out weekly emails highlighting women of the AANHPI community, women of the disability community, women of the LGBTQ2IA+ community, and women who dedicated their work to women’s rights. The Committee also recognized the countless contributions of Supreme Court Justice Ruth Bader Ginsburg to women everywhere.

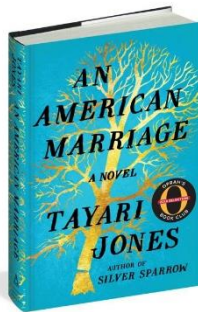

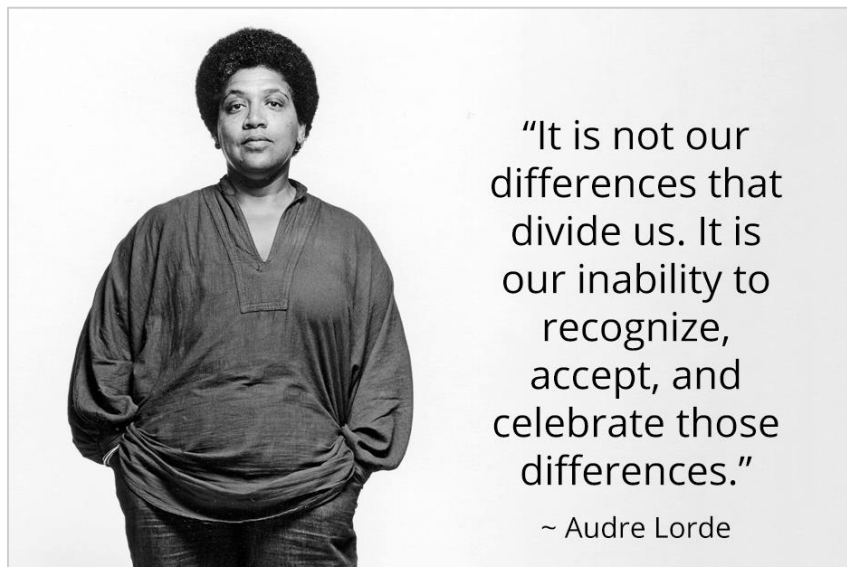

Haitian Heritage month was created to celebrate the culture of Haiti even in the United States. It quickly became a fun and positive way for *Haitian-Americans* to express their pride for their country. With the most iconic event being Haitian Flag Day, celebrated on May 18, Haitians all over the United States come together to celebrate their culture and heritage.

Dessalines Park is home to one of the largest populations of Haitian immigrants in the United States and became the first City to celebrate May as Haitian Heritage Month in 1998. In years past, Haitian Flag Day was commemorated in Boston with a parade along Blue Hill Avenue through Dorchester and Mattapan.

The Haitian community in Boston is incredibly active, with several community organizations based here, including Haitian Americans United, *Association of Haitian Women in Boston*, *Haitian American Public Health Initiatives, Inc.*, the Haitian Nurses Association (HNA), the *Boston Haitian Reporter*, as well as over 100 small businesses.

Although the pandemic has changed how this culturally powerful month is celebrated, we can continue to enjoy Haitian Heritage virtually.

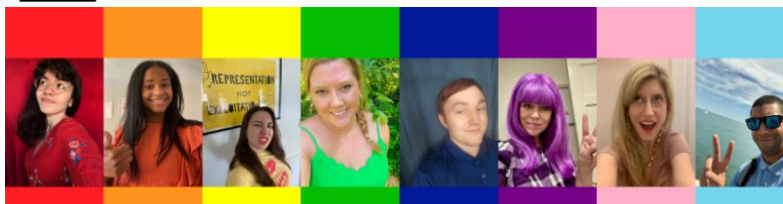
The Diversity, Equity, and Inclusion Committee Celebrates Immigrant Heritage and Pride [Spring 2021]

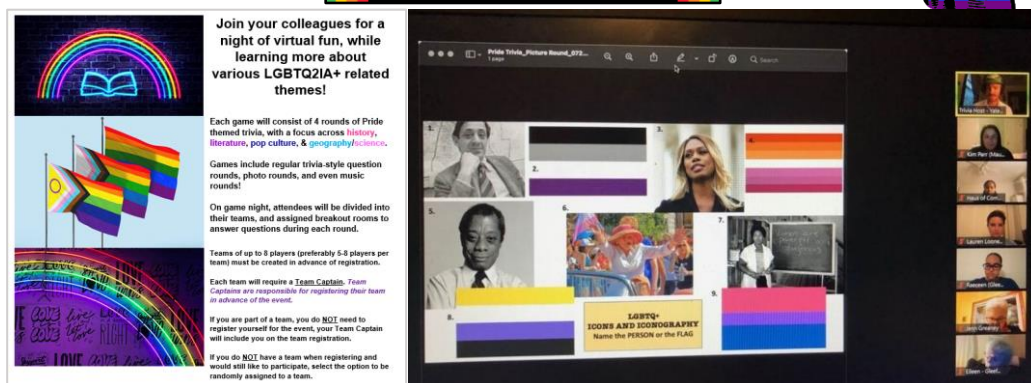
Pride 2021 Continued [Spring / Summer 2021]

The Committee also featured **HCD Mediator Sasha Restrepo** in the AGO Weekly Roundup and highlighted her Colombian heritage.

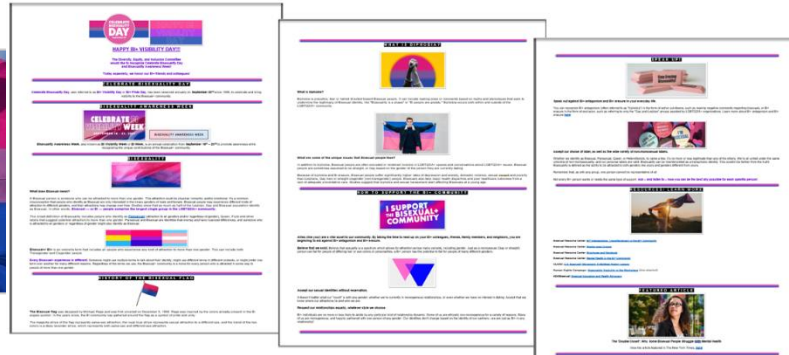

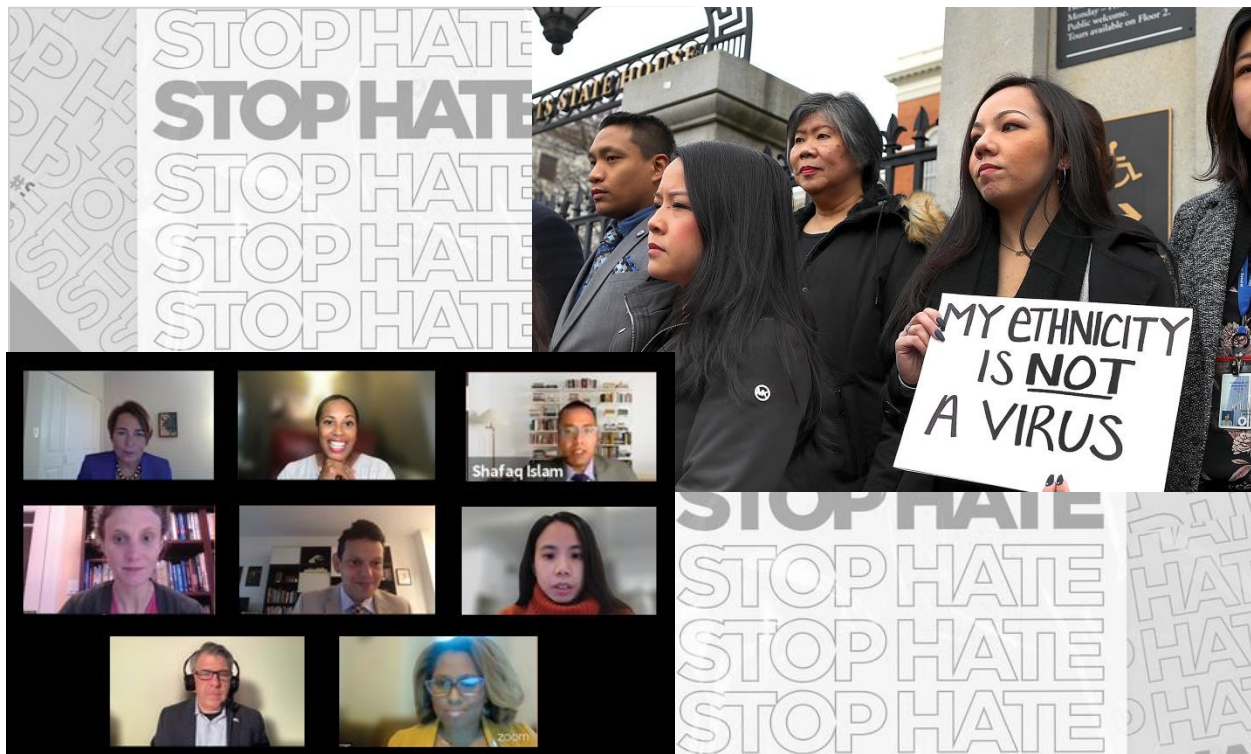

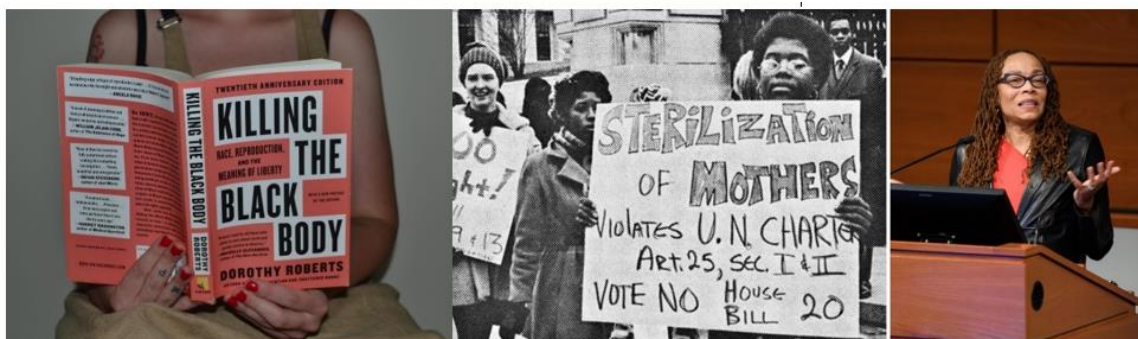


Also in *November of 2021*, the Office convened two of its Advisory Councils, the Racial Justice and Equity Advisory Council and the New Americans Advisory Council.

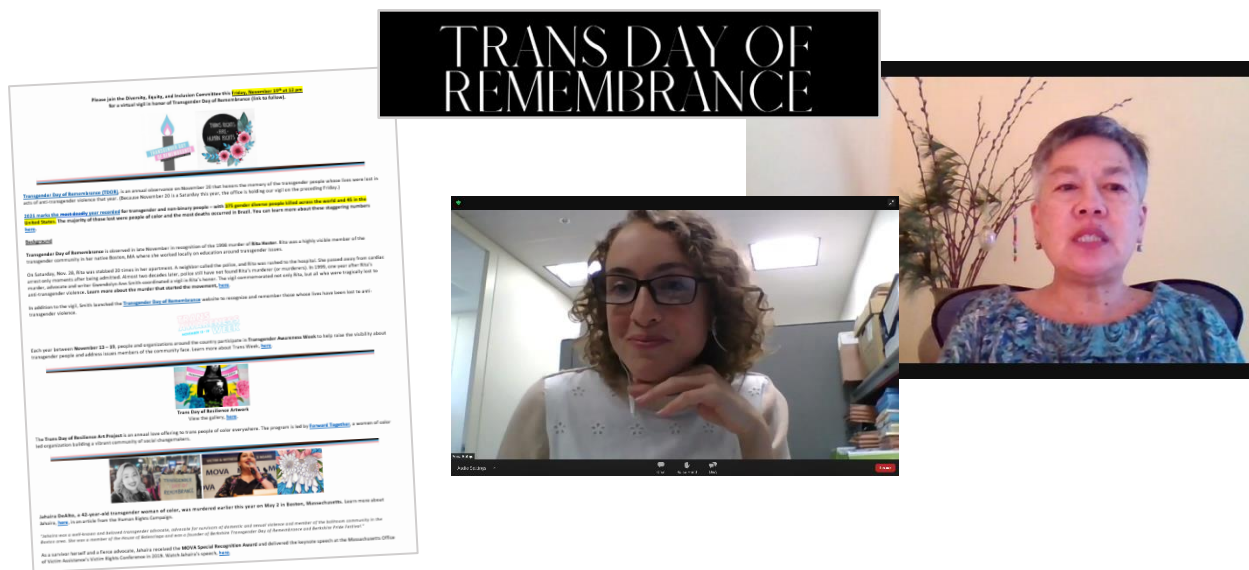

One of the names on the list was Boston's Jahaira DeAlto Balenciaga. May she rest in power. This powerful vigil is an important reminder of the work we must do to protect Trans people from violence and hate.



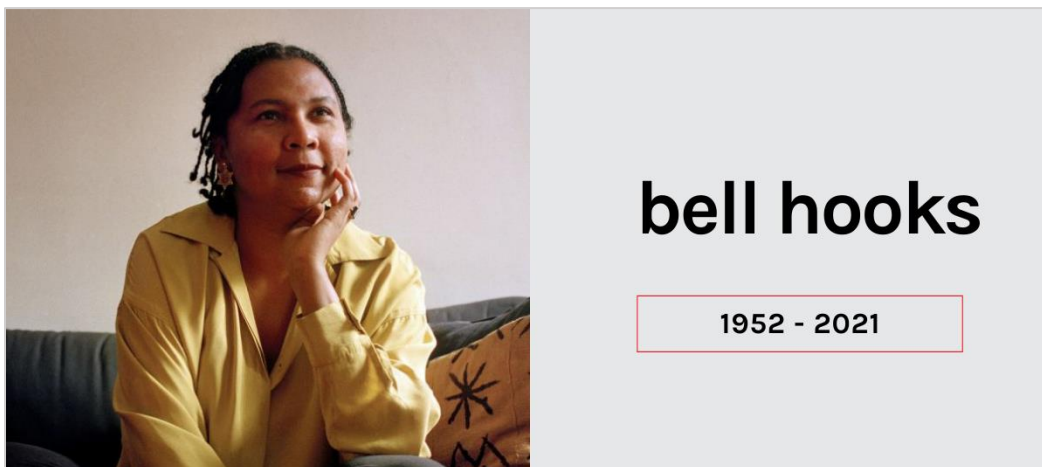

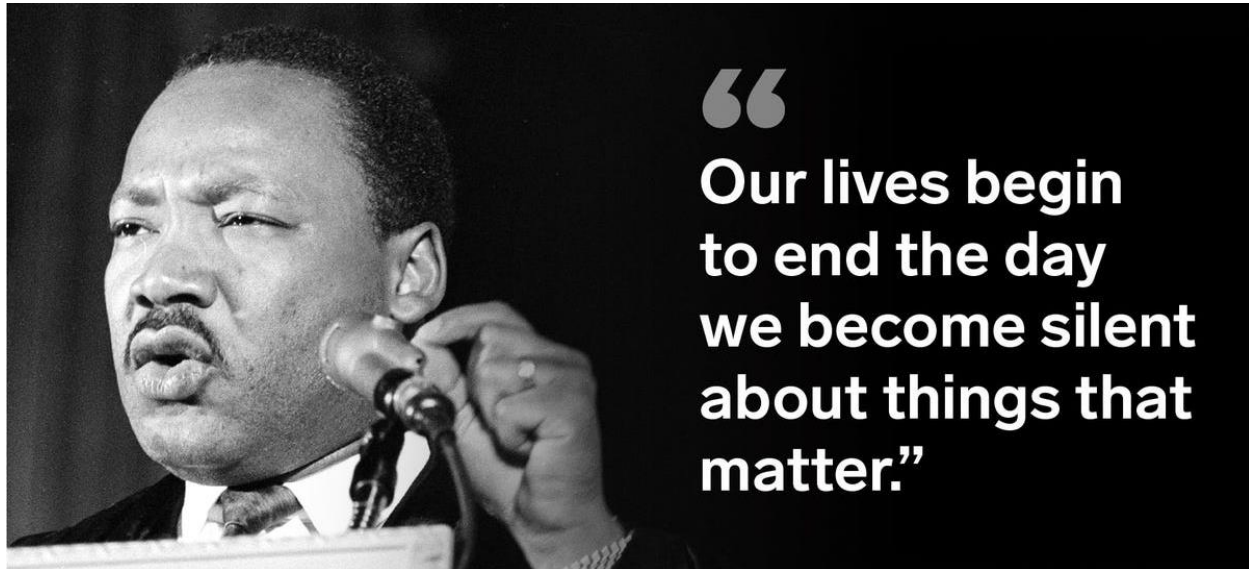
