DECISION

ORLEANS WATERFRONT INN, INC. D/B/A ORLEANS WATERFRONT INN 3 OLD COUNTY ROAD

ORLEANS, MA 02653 LICENSE#: 0934-00058

VIOLATION DATE: 07/20/2017 HEARING DATE: 11/07/2017

Orleans Waterfront Inn, Inc. d/b/a Orleans Waterfront Inn (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission" or "ABCC") held a hearing on Tuesday, November 7, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Velez's Report.

The following documents are in evidence:

- 1. Investigator Velez's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Thursday, July 20, 2017, at approximately 6:28 p.m., Investigators Binienda and Velez ("Investigators") investigated the business operation Orleans Waterfront Inn, Inc. d/b/a Orleans Waterfront Inn.
- 2. An underage operative, working with Investigators, was served an alcoholic beverage, a bottle of Bud Light beer. The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 20 years with no prior violations, the Commission issues a **WARNING**.
